1. I/we acknowledge that all aspects of the **Marcellus Girls Lacrosse Club** activities and programs are designed and run by volunteers, serving in good faith to provide a positive lacrosse and life experience to all participants.
2. I/we agree that I/we will instruct our Daughter that prior to participating she must inspect the facilities and equipment to be used, and if she believes anything is unsafe, she must immediately advise her coach or supervisor of such condition and refuse to participate.
3. I/we acknowledge and fully understand that our Daughter will be engaging in activities that involve risk of serious injury, including permanent disability and death, and severe social and economic losses which might result not only from her own actions, inactions or negligence, but also the action, inaction or negligence of others (including the Releasees as defined below), the rules of play, or the condition of the premises or of any equipment used, and that there may be other risks not known or not reasonably foreseeable at this time.
4. I/we assume all the foregoing risk and accept personal responsibility for the damages caused by such injury, permanent disability or death.
5. I/we release, waive, discharge and covenant not to sue the **Marcellus Girls Lacrosse Club**, its members, administrators, coaches, players, and other volunteers; its affiliated organizations their administrators, directors, agents, coaches, and other; other participants; sponsoring agencies, sponsors, advertisers; and owners and lessees of premises used to conduct any event, all of which are referred to in this waiver and release as "Releasees", from any and all liability to each of the undersigned and his or her heirs and next of kin for any and all claims, demands, losses, or damages on account of injury, including death, or damage to property, caused or alleged to be caused in whole or in part by the negligence of Releasees or by any other reason.
